
VOGUE TYRE PASSENGER AND LIGHT TRUCK REPLACEMENT TYRE EXCLUSIVE LIMITED WARRANTY & TREADWEAR WARRANTY

You are eligible for the benefits set forth below if you are the original owner of any Vogue Tyre bearing our name and serial numbers that have been used exclusively on the passenger vehicle on which they were originally installed. These benefits are available only for tyres that were purchased on or after January 1, 2019 and used by you in the 50 United States and Canada.

VOGUE TYRE passenger and light truck replacement tyres that are used in normal service on the vehicle on which they were originally fitted are covered as follows:

1. Craftsmanship Assurance

Vogue warrants exclusively to you that the Tyres will be free from defects in materials and workmanship. If any Tyre becomes unusable due to a breach of this limited warranty during the first 4/32" of the Tyre's original tread life, as measured by the depth of tread remaining, Vogue will replace the Tyre with a comparable new Vogue tyre at no charge. Such replacement will also be made for any ride complaints or cosmetic defects caused by a breach of this limited warranty during the first 2/32" of the Tyre's original tread life. If any Tyre becomes unusable after the first 4/32" of the Tyre's original tread life due to a breach of this limited warranty, Vogue will give you a credit against the purchase price of a comparable new Vogue tyre based on the percentage of the depth of the Tyre's tread then remaining. You will be responsible for any related charges including installation or other labor, taxes, etc. Warranty claims are valid for 60 months starting from the date of manufacture stamped on the Tyre. This paragraph sets forth Vogue's entire and exclusive obligations for any breach of this limited warranty. Such obligations will be subject to the conditions described under Causes Not Covered, Requirements, Scope of Obligations, and Limits on Liability stated below.

2. 60,000 Mile Mileage Expectancy

The "life of the usable tread" refers to the original tread worn down evenly, shoulder to shoulder circumferentially, to the level of the treadwear indicators, which is 2/32nds of an inch (1.6 mm) of tread remaining. Uneven wear is defined as wear of one area, faster than the adjacent tread. If the tyre treadwear does not reach its mileage warranty a pro rata replacement of the tyre may be available under this warranty. Tyre must be evenly worn with a tread groove difference less than 2/32 of an inch, from shoulder to shoulder. To maintain the treadwear warranty on your tyres, the tyres must be rotated every 6,000 - 8,000 miles (10,000 -12,000 km), or as recommended by the vehicle manufacturer, whichever rotation period is less. Failure to rotate the tyres as provided herein voids the treadwear warranty. Note that if you use different size tyres on the front and rear axles, your tyres cannot be rotated as recommended by Vogue Tyre. As a result, the mileage warranty on each tyre will be half that specified.

3. 30 Day “Buy and Try” Guarantee

Any Tyres sold in sets of 4 or more through an authorized retailer are covered by Vogue’s “Buy and Try” Guarantee. If a retail customer is not completely satisfied with his or her eligible Tyres, the tires can be returned to the location where they were originally purchased within 30 calendar days of purchase for a full refund or exchange. Installation charges, valves, and other related service charges, expenses, and taxes are not covered. Original proof of purchase is required. Returns of less than a full set of tires will not be accepted. Tires driven more than 2,000 miles are not eligible for this warranty. Tires damaged by road hazard, misuse, misapplication, mechanical problems related to the vehicle, misalignment, improper inflation, overloading or other such issues are not eligible. This “30 Day Buy and Try Guarantee” applies only to the original tires purchased and not to the tires provided under this guarantee.

4. Roadside Tyre Assistance

If any Tyre loses air for any reason to the extent that it cannot be driven to a nearby service station for repair, Vogue will, in addition to any remedies provided above: a. Pay for your road service, from the nearest service point, to replace the Tyre with a spare tire; or (\$75.00 maximum) b. Pay for the cost to repair the flat Tyre (\$20 maximum).

5. Trip Delay Replacement Guarantee

If any Vogue Tyre becomes unusable and cannot be repaired and the customer is unable to obtain a replacement Vogue Tyre, Vogue will reimburse the customer for a non-Vogue brand replacement tire purchased to temporarily replace the unusable Vogue tyre. Such reimbursement will be made only when the customer subsequently purchases a Vogue Tyre and submits the other brand replacement tire to Vogue. Reimbursement is limited to \$120 and does not include any installation charges, valves, or other related service charges, expenses, or taxes. Other brand replacement tires driven more than 500 miles are not eligible for this warranty. Original proof of purchase of the non-Vogue brand tire is required. Customer must present unusable Vogue tyre to a Vogue authorized dealer to qualify for reimbursement. Charges relating to the replacement Vogue tyre will be determined in accordance with Vogue’s overall Exclusive Limited Warranty.

WHAT IS NOT COVERED

This warranty does not cover tyres damaged due to misuse, abuse or accident such as:

- Road hazards (e.g., cuts, snags, bruises, impact damage or punctures).
- Incorrect mounting of the tyre, tyre/wheel imbalance or improper repair.
- Misapplication, improper maintenance, racing, underinflation, overinflation or other abuse.
- Uneven wear (to include all wear types).
- Wear caused by mechanical irregularity in the vehicle such as wheel misalignment.

- Sidewall appearance issue due to the use of harsh or abrasive cleaning agents, chemicals containing bleach or other rubber degrading agents, wire brushes, steel wool or other such implements may damage the Tyre sidewall and will negate Vogue's obligations under paragraphs 1 and 2. Vogue recommends using a soft brush with a non-abrasive cleaner such as Vogue Whitewall Cleaner for cleansing.
- Accident, fire, chemical corrosion, tyre alteration or vandalism.
- Flat spotting caused by improper storage or brake lock;
- The addition of liquid, solid or gaseous materials other than air, nitrogen or carbon dioxide (for example, waterbase sealers or balancing substances);
- Minor cosmetic ozone or weather cracking.

Other limitations include but are not limited to the following:

- Failure to rotate your tyres as recommended by Vogue Tyre voids the treadwear warranty.
- The mileage warranty on each tyre will be half that specified for tyres that cannot be rotated as recommended by Vogue Tyre because the tyre size on the front axle of the vehicle is different from that on the rear axle.
- No treadwear warranty for tyres used in commercial applications (such as mail carrier, taxi cab or ride sharing vehicles).
- You must be the original purchaser of tyres to participate in the Vogue Tyre Warranty.

WHAT WILL VOGUE TYRE DO?

Workmanship/Materials

If a tyre is covered, and 4/32nds of an inch (1.6 mm) or less of the original tread is worn (or 50% or less, whichever is more beneficial to you), and it is within 12 months of the date of purchase, Vogue Tyre will, free of charge, replace your tyre with a comparable new VOGUE TYRE replacement tyre, mount the tyre, and balance the tyre. You must pay the cost of any other service charges and applicable taxes. If a tyre is covered, and more than 4/32nds of an inch of original tread has been worn (or more than 50%, whichever is more beneficial to you), or it has been more than 12 months from the date of purchase, Vogue Tyre will replace the tyre with a comparable new VOGUE TYRE replacement tyre on a pro rata basis. This means that you will be responsible for paying a portion of the cost. The Vogue Tyre retailer will determine the portion for which you will be responsible by multiplying the percentage of the original usable tread worn, by the current selling price of the replacement tyre at the adjustment location. You also will be responsible for paying in-full the cost of mounting and balancing the tyre, and the cost of any other service charges and applicable taxes.

Treadwear

If a tyre is covered and wears out evenly across the face of the tread before delivering the warranted mileage, Vogue Tyre will replace the tyre with a comparable new VOGUE TYRE replacement tyre on a pro rata basis. This means that you will be responsible for paying a portion of the cost. The Vogue

Tyre retailer will determine the portion for which you will be responsible by multiplying the percent of mileage received by the current actual selling price at the adjustment location or the price of the tyre in the current Vogue Tyre Base Price List, whichever is lower. You will be responsible for paying in-full the cost of mounting and balancing the tyre, and the cost of any other service charges and applicable taxes. Tyres which wear out evenly before delivering the warranted mileage will be replaced on a pro rata basis only if:

1. You are the original purchaser of the tyres, you own the vehicle on which they were originally installed, and the tyres have been used only on that vehicle.
2. The tyres have been rotated and inspected every 6,000-8,000 miles (10,000-12,000 km), or as specified by your vehicle manufacturer, whichever rotation period is less, and the Mounting and Rotation Service Record has been fully completed and signed.
3. A completed Service Record form, Original Owner/Tyre Installation Information form, and the original Invoice are presented to a participating Vogue Tyre retailer at the time of adjustment claim, and
4. The tyres have not become unserviceable due to a condition listed under WHAT IS NOT COVERED.

Vogue Tyre's Obligation

Replacements qualifying under the warranty must be made by an authorized Vogue Tyre dealer.

Dealer's Obligation

To process mileage proration adjustment(s) for the customer, the tire dealer must validate the mileage received on the claim tire(s), versus the mileage warranted and certify this information on the claim form to Vogue Tyre and provide proof of rotation documents to the claim form.

Customer's Obligation

The customer must present the claim tire to the authorized Vogue Tyre retail tire dealer where the tyres were purchased. To obtain prorated adjustments, the customer needs to provide proof of original purchase from authorized Vogue Tyre dealer for the claim tire(s) that states the vehicle mileage at the time of the original installation. Additionally, the customer must provide proof that the tires have been rotated regularly as noted above. The customer will be required to pay for any services, labor and applicable sales or other taxes. Claims under paragraphs 1-4 above are only valid for and must be submitted within 60 months starting from the date of manufacture stamped on the Tyre.

Scope of Obligations.

THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE. THE FOREGOING PROVISIONS CONSTITUTE THE EXCLUSIVE

EXPRESS WARRANTIES AND CREDIT OBLIGATIONS OF VOGUE REGARDING THE TYRES SOLD TO YOU. TO THE EXTENT LEGALLY PERMISSIBLE, NO IMPLIED WARRANTIES REGARDING THE TYRES, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE APPLICABLE; TO THE EXTENT ANY SUCH IMPLIED WARRANTIES APPLY, THEY SHALL BE LIMITED IN TIME TO THE DURATION OF THE LIMITED WARRANTY SET FORTH ABOVE. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU. NO EMPLOYEE OR AGENT OF VOGUE IS AUTHORIZED TO MAKE ANY REPRESENTATION, WARRANTY OR REPLACEMENT OR CREDIT AGREEMENT REGARDING THE TYRES ON BEHALF OF VOGUE EXCEPT TO THE EXTENT SPECIFICALLY STATED HEREIN. THE SALE OF TYRES TO YOU IS CONDITIONED ON YOUR ACCEPTANCE OF THE TERMS HEREIN. NONE OF SUCH TERMS MAY BE MODIFIED AND ANY DIFFERENT OR ADDITIONAL TERMS PROPOSED BY YOU RELATING TO THE TYRES WILL NOT APPLY, UNLESS CONSENTED TO IN WRITING BY VOGUE. *Limits on Liability.* VOGUE WILL HAVE NO WARRANTY, CONTRACT TORT OR OTHER LIABILITY OR OBLIGATIONS TO YOU WITH RESPECT TO ANY TYRE (A) IN EXCESS OF THE PRICE PAID BY YOU FOR THE TYRE OR (B) FOR ANY INCIDENTAL, CONSEQUENTIAL, INDIRECT, PUNITIVE OR SPECIAL DAMAGES, HOWEVER CAUSED, INCLUDING BUT NOT LIMITED TO DAMAGES FOR ANY LOSS OF USE OF VEHICLES OR OTHER PROPERTY, INCONVENIENCE, DELAYS, LOST PROFITS OR THIRD PARTY CLAIMS AGAINST YOU WHETHER OR NOT VOGUE HAS BEEN ADVISED OF SUCH DAMAGES OR REASONABLY COULD HAVE FORESEEN THE POSSIBILITY OF SUCH DAMAGES. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. Contact Information.
